

Terms & Conditions

1. Registration and Payment

- All delegates are required to complete their registration online through the official Summit registration portal.
- Full payment is required at the time of registration to confirm your participation. Your registration is only considered confirmed upon receipt of the full payment.
- Registrations will be confirmed within three working days after the full payment is received.
- Accepted payment methods include credit/debit card, bank transfer, QR Code/UPI, and other options specified on the registration portal.

2. Cancellation and Refund Policy

a. Cancellations by Attendee:

- Cancellations received on or before December 30th, 2024 will be eligible for a 70% processing fee of INR 2500.refund, minus a processing fee of INR 2500.
- No refunds will be issued for cancellations received on or after January 1st, 2025.
- All cancellation requests must be submitted via email to sec.general@bslms2025.com and secretariat@bslms2025.com

b. Cancellations by Organizer:

- In the unlikely event that the Summit is canceled by the organizers, attendees will receive a full refund of the registration fee.

3. Substitution Policy

- If you are unable to attend, you may transfer your registration to another individual within your organization for an additional fee of INR 5000 per delegate.
- Substitutions must be communicated to the Secretary General of the Summit in writing at least 20 days prior to the event.

4. Event Changes

- The Summit organizers reserve the right to make changes to the scientific program, speakers, and venue if necessary.
- Any significant changes will be communicated to registered participants in advance.

5. Liability

- The Summit organizers are not responsible for any personal injury, loss, or damage to property that may occur during the event.
- Delegates are responsible for securing their own travel and accommodation arrangements.

6. Privacy and Data Protection

- Personal information collected during registration will be used solely for the management of the Summit and will not be shared with third parties without your consent.
- By registering, you agree to receive communications from the organizers regarding the conference and related events.

7. Photography and Recording

- Photography, filming, or other forms of recording of the Summit are prohibited.
- By attending the Summit, you consent to being photographed and recorded, and you grant the organizers the right to use such media for promotional purposes.
